Dear Administrative Judges:

In its Order dated January 8, 2009, the Atomic Safety and Licensing Board ("Board") directed the NRC staff ("Staff"), commencing on January 15, 2009, to tender each month "a short report advising as to whether the estimated dates for issuance of the final [Safety Evaluation Report ('SER')] (predicted for summer/fall of 2009) and final [environmental review document] (predicted for December of 2009) have changed or become more definitive." The Staff is currently waiting for a response from the Applicant regarding a proposed license condition. As such, the Staff now expects to issue the SER by the end of August 2012. While the Staff continues to expect at this time to issue the final environmental review document by November 2012, the Staff would note that there is a possibility of delay (up to a few months) due to time potentially needed to accomplish activities pursuant to Section 106 of the National Historic Preservation Act.

In keeping with the Board's mandate, the Staff will tender its next monthly status report by August 16, 2012.
