Dear Freedom of Information / Open Records Officer:

Pursuant to the Federal Freedom of Information Act, 5 U.S.C. § 552, and all other applicable state and federal statutes, we request from your department / agency (and all divisions and agencies under your jurisdiction), all publicly available documents including, but not limited to:

- Any and all records of communication (including but not limited to letters, written requests, reports, telephone records, electronic communication, complaints, investigations, violation and memos) between your department (and all divisions and agencies under your jurisdiction) and the following individuals:

- 1) George Felix Allen, or his offices for the following dates:
  - 2000-current, when Allen has been U.S. Senator
  - 1993-1997, when Allen was Virginia Governor
  - 1991-1992, when Allen was U.S. House of Representatives
  - 1982-1991, when Allen was a member of Virginia House of Delegates
- 2) Haley Reeves Barbour, or his offices for the following dates:
  - 2003-Present, when Barbour was Governor of Mississippi
  - 1993-1997, when Barbour was Chairman of the Republican National Committee
  - 1991-2003, when Barbour was CEO of Barbour, Griffith & Rogers
  - 1985-1987, when Barbour was Director of the White House Office of Political Affairs
  - 1982, when Barbour was a candidate for U.S. Senate
  - 1969-1970, when Barbour was State Director for the US Census Bureau
- 3) Samuel Dale Brownback, or his offices for the following dates:
  - 2000-current, when Brownback has been a U.S. Senator
  - 1994-2000, when Brownback was a member of the U.S. House of Representatives
  - 1990-1991, when Brownback was White House Fellow, Office of the U.S. Trade Representative
  - 1986-1993, when Brownback was the Kansas Secretary of Agriculture
  - 1983-1986, when Brownback was City Attorney for Ogden & Leonardville for two places
  - 1982-1986, when Brownback was a Professor at Kansas State University Law School
- 4) William Harrison Frist, or his offices for the following dates:
  - 1994-current, when Frist has been a U.S. Senator
- 5) Newton ("Newt") Leroy Gingrich, or his offices for the following dates:
  - 1999-2001- Served on the U.S. Commission on National Security/21st Century.

-1979-1999, when Gingrich was U.S. Representative for the Sixth District of Georgia, including 1981-1994, when he was minority whip and 1994-1998, when he was Speaker of the House

- 6) Rudolph ("Rudy") William Louis Giuliani III, or his offices for the following dates:
  - 1993-2001, when he was Mayor of the City of New York
  - 1983-1989, when he was U.S. Attorney for Southern District of New York
  - 1981-1983, when he was Associate Attorney General and Supervising U.S. Attorney
  - 1975-1977, when he was Associate Deputy Attorney General and chief of staff to Deputy Attorney General Harold R. Tyler
  - 1970-1975, when he was in the U.S. Attorney's Office, including 1973-1975, when he was Chief of the Narcotics Unit and Executive U.S. Attorney
- 7) Charles ("Chuck") Timothy Hagel, or his offices for the following dates:
  - 1996-current, when Hagel has been a member of the U.S. Senate
  - 1990, when he was Deputy Director of Economic Summit of Industrialized Nations
  - 1987, when he was President of the World USO
  - 1980, when Hagel was deputy administrator for the Department of Veteran's Affairs
  - 1971-1977, when Hagel was an aide for Nebraska Congressman John Y. McCollister
  - 1977-1979, when Hagel was a lobbyist for Firestone Tire and Rubber
- 8) Michael Huckabee, or his offices for the following dates:
  - 1996-current, when Huckabee has been Governor of Arkansas
  - 1993-96, when Huckabee was Lt. Governor of Arkansas
- 9) John Sidney McCain III, or his offices for the following dates:
  - 1986-current, during which time McCain has been a member of the U.S. Senate
  - 1982-1986, during which time Sen. McCain was in the U.S. House of Representatives
- 10) George Elmer Pataki, or his offices for the following dates:
  - 1995-current, when Pataki has been Governor of New York
  - 1993-1994, when Pataki served in the New York State Senate
  - 1985-1992, when Pataki served in the New York State Assembly
  - 1982-1984, when Pataki was Mayor of Peekskill, New York
- 11) Willard Mitt Romney, or his offices for the following dates:
  - 2002-current, when Romney has been Governor of Massachusetts
  - 1999-2002, when Romney was CEO of the Salt Lake Organizing Committee (2002 Winter Olympics)

- Any and all freedom of information requests filed since January 1, 2002 with your department / agency (and all divisions and agencies under your jurisdiction) mentioning the aforementioned George Allen, Haley Barbour, Samuel Brownback, William Frist, Newt Gingrich, Rudolph Giuliani, Charles Hagel, Michael Huckabee, John McCain, George Pataki, or Willard Mitt Romney.
- If this request would generate a substantial number of documents, we would prefer to have an index of the documents. Of course, this request for an index does not preclude us from later requesting any or all of the documents included in the index. Additionally, we request that the information we seek be provided, if possible, in an electronic format via a personal computer disk or CD-ROM.

We understand that there might be costs associated with this request. We request a waiver of fees and ask for you to contact either of us by telephone before making copies if this request will be in excess of \$25.

We would appreciate your communicating with us by telephone at (b)(6) rather than by mail, if you have questions regarding this request. We look forward to your reply within 20 business days (excluding Saturdays, Sundays and legal holidays), as the statute requires.
