

The purpose of this modification is to incrementally fund the contract in the amount of \$10,170, which increases the obligated amount from \$272,725.84 to \$282,895.84.

Accordingly, the following changes are hereby made:

1. Section A.3 CONSIDERATION AND OBLIGATION—TIME AND MATERIALS, paragraph (b) is hereby deleted in its entirety and replaced with the following:

- (b) The amount presently obligated with respect to this contract is \$282,895.84. The obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph (a) above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.

A summary of obligations, from date of award through this modification, is given below:

FY'10 obligation amount: \$105,000.00

FY'11 obligation amount: \$105,051.84

FY'12 obligation amount: \$ 72,844.00
