By letter dated June 13, 2012, Florida Power and Light Company (the licensee) submitted for a license amendment request (LAR) to the Renewed Facility Operating Licenses (RFOL) for Turkey Point Units 3 and 4. The proposed LAR requested a change to the description of the milestone 6 activity in the NRC Issued license amendments Nos. 245 and 241 for Turkey Point Units 3 and 4, respectively. The purpose of this letter is to provide the results of the U.S. Nuclear Regulatory Commission (NRC) staff's acceptance review of this LAR. The acceptance review was performed to determine if there is sufficient technical information in scope and depth to allow the NRC staff to complete its detailed technical review. The acceptance review is also intended to identify whether the request has any readily apparent information insufficiencies in its characterization of the regulatory requirements or the licensing basis of the plant.

The NRC staff has reviewed your application and concluded that it does provide technical information in sufficient detail to enable the NRC staff to complete its detailed technical review and make an independent assessment regarding the acceptability of the proposed amendment in terms of regulatory requirements and the protection of public health and safety and the environment. Given the lesser scope and depth of the acceptance review as compared to the detailed technical review, there may be instances in which issues that impact the NRC staff's ability to complete the detailed technical review are identified despite completion of an adequate acceptance review.
