The purpose of this modification is:

(1) exercise option year one in accordance with FAR clause 52.217-9, entitled "Option to extend term of the contract, thereby extending the contract period of performance through 9/30/13, thereby increasing the current ceiling from \$358,209.12 to \$855,182.01; and (2) to provide funding in the amount of \$195,000.00, thereby increasing the firm fixed price amount of this contract from \$358,209.12 to \$553,209.12.

Accordingly, the following changes are hereby made:

**Section B.2 – CONSIDERATION AND OBLIGATION – COST REIMBURSEMENT—NO FEE (AUG 2011) ALTERNATE I (AUG 2011)**, is deleted in its entirety and replaced with the following in lieu thereof:

(a) The total estimated cost to the government for full performance under this contract is \$2,437,358.32.

(b) The amount presently obligated by the government with respect to this contract is \$553,209.12. The Contracting Officer may issue orders for work up to the amount presently obligated.

(c) It is estimated that the amount currently obligated will cover performance through September 20, 2013.

(d) This is an incrementally funded contract and FAR 52.232.22 "Limitation of Funds" applies.
