SUBJECT: ISSUANCE OF COMBINED LICENSES FOR V. C. SUMMER NUCLEAR
STATION (VCSNS) UNITS 2 AND 3

Dear Mr. Clary:

The U.S. Nuclear Regulatory Commission (NRC) has issued Combined Licenses (COLs) NPF-93 and NPF-94 to South Carolina Electric and Gas Company and South Carolina Public Service Authority pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Section 52.97, "Issuance of Combined Licenses." These licenses were issued after receiving the report of the Advisory Committee on Reactor Safeguards dated February 17, 2011, and as authorized by the Commission's hearing decision dated March 30, 2012.

Enclosed are copies of NPF-93 and NPF-94, (Enclosures 1 and 2, respectively) including the Technical Specifications (Appendix A), the Environmental Protection Plan (Appendix B), and the Inspections, Tests, Analyses, and Acceptance Criteria (Appendix C) for the V. C. Summer Nuclear Station Units 2 and 3, respectively. Please note that Attachment 1 to Appendix C for NPF-93 and NPF-94 contains security-related information and as such, it is withheld from public disclosure. A related notice will be forwarded to the Office of the Federal Register for publication.

Three copies of Amendment No. 4 to Indemnity Agreement No. B-86 which cover the activities authorized under Licenses NPF-93 and NPF-94 are included as Enclosure 3. Please countersign all the copies and return one signed copy to this office.
