Dear Mr. Laughlin:

This letter confirms our discussion on December 20, 2011, during which you were informed that the NRC has authorized the introduction of uranium hexafluoride into Cascade 6 at the Louisiana Energy Services (LES), URENCO USA Facility located in Eunice, New Mexico. This authorization is pursuant to the provisions of Part 70, Paragraph 70.32(k) and 10 CFR 40.41 (g) of Title 10 of the *Code of Federal Regulations* (CFR) that states, "No person may commence operation of a uranium enrichment facility until the Commission verifies through inspection that the facility has been constructed in accordance with the requirements of the license."

This NRC authorization is based on the results of construction and quality assurance inspections of Cascade 6 described in the inspection reports listed in the enclosure. The NRC staff determined that the systems, structures, and components designed to support safe operation of Cascade 6 were constructed in accordance with the requirements of your license. Specifically, our inspections provided: (1) reasonable assurance that the design, construction, and implementation of items relied on for safety (IROFS) will protect against natural phenomena and the consequences of potential accidents, (2) verification that the Quality Assurance Program was adequately implemented during construction; and (3) verification that the construction of the IROFS was completed in accordance with the documents comprising the license and the Integrated Safety Analysis.

During our inspections, the NRC staff reviewed and inspected procurement, receipt inspections, installation and testing of the Cascade 6 centrifuge header piping, upper and lower steelworks and flomels for compliance to Quality Level 1 requirements. The staff also conducted interviews with LES staff and contractor personnel including employees in operations, technical support and management. The publically available inspection reports that describe the construction and quality assurance inspections of Cascade 6 are accessible through the NRC's public electronic reading room, Agency-wide Document Access and Management System (ADAMS) at <http://www.nrc.gov/reading-rm/adams.htm> at the accession numbers listed in the enclosure.

Please note that this authorization does not apply to any cascades other than Cascade 6, and it does not apply to processes or components associated with future phases of facility operations.
