A provisional license was issued on January 5 in conjunction with asking the licensee if they wanted to request a hearing (CDPHE should have asked the public at this point if anyone wanted a hearing). When the licensee did not request an hearing, the State issued the final license on March 7. As far as Dennis and I know, the license is still in good standing (see below).
