The purpose of this modification is to 1) exercise option year three, and 2) add incremental funds for this task order in the amount of \$872,957.00, thereby increasing the total obligated amount from \$8,695,723.84 to **\$9,568,680.84**.

Accordingly, the following changes are hereby made:

A.3 CONSIDERATION AND OBLIGATION, second paragraph is revised to read as follows:

"The amount presently obligated with respect to this delivery order is **\$9,568,680.84**. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this delivery order. The obligated amount shall, at no time, exceed the delivery order ceiling specified above. When and if the amount(s) paid and payable to the contractor hereunder shall equal the obligated amount, the contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this delivery order. Any work undertaken by the contractor in excess of the obligated amount specified above is done so at the contractor's sole risk."

All other terms and conditions remain unchanged.
