The purpose of this modification is to:

1. Exercise the Government's unilateral right to exercise an option in accordance with the contracts clause FAR 52.217-4 Option to Extend the Term of the Contract. Accordingly, the full contract period of performance is changed to read:

MARCH 16, 2012 – September 25, 2013"

The Government hereby exercises Option No. 1 at the rates priced in Section B of the contract.

2. Increase the task order ceiling by \$9,864.17, from \$9,776.81 to \$19,640.98. Accordingly, paragraph (a) under section 4 Consideration and Obligation-Time and Materials Contract (August 2011) is revised to read as follows:

"(a) Currently, the ceiling price to the Government for full performance under this contract is \$19,540.98."

All other terms and conditions remain unchanged.
