Dear Administrative Judges:

Pursuant to 10 C.F.R. §§ 2.1203 and 2.336 and as modified by the Atomic Safety and Licensing Board's ("Board") Memorandum and Order dated June 15, 2011 ("Order"), the staff of the Nuclear Regulatory Commission ("Staff") is providing an index identifying documents subject to disclosure under the Board's Order. On or about August 7, 2012, materials in the hearing file may be accessed through the Agencywide Documents Access and Management System ("ADAMS") and through the Electronic Hearing Docket ("EHD").
