This letter is in reference to your June 27, 2012 e-mail requesting additional information for processing of our June 15, 2012 renewal application for NRC License Number 53-29047-01. The requested additional information, along with our responses in *italic*, are indicated below.

1. Please establish maximum possession limits for the Cs-137 and Americium-241 requested. You may establish a MPL that will allow you to purchase additional gauges from the same manufacturer and portable gauge model.

It will sufficient to use the MPLs indicated on our current material license:

- A. Cesium-137 – 9 millicuries each and 45 millicuries total
- B. Americium-241 – 44 millicuries each and 220 millicuries total

2. Please confirm you will implement and maintain the operating, emergency and security procedures in Errata: Appendix H of NUREG-1556 Vol. 1 Rev. 1, Dated November 2001, and provide copies of these procedures to all gauge users and at each job site.

We will implement and maintain the operating, emergency, and security procedures in Appendix H of NUREG-1556.
