The applicant requested clarification on RAI 12. Also, the applicant stated that they did not plan to develop the details required to respond to RAIs 5, 6, 8, 9, 10, and 11 until the planned inspections are to take place. The applicant indicated that the inspections were expected to commence in 2014 for IP Unit 2 and 2015 for IP Unit 3. The staff indicated that they would have an internal discussion on the applicant's planned response and would contact the applicant to provide feedback on its planned response.
