Dear Mr. Flageolle:

This refers to your application dated May 11, 2012, notifying the NRC of the transfer of ownership and control of License 24-18683-01 issued to Bucher, Willis & Ratliff Corporation.

The transferee should note their new responsibility and liability as an NRC licensee. Specifically, responsibility is emphasized with regard to any ongoing NRC inspection and enforcement issues, investigations, facility decontamination and decommissioning funding resources. Please be advised, change of ownership/control cannot be transferred without **prior written consent** from the NRC (10 CFR 30.34 (b)). You should have received a "Notice of Violation", regarding this matter by separate correspondence. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which the NRC expects of its licensees.

Also, in the NRC Form 314 dated May 11, 2012, you contacted the U.S. Nuclear Regulatory Commission and indicated that you wished to terminate your NRC radioactive material license. Based upon the information submitted NRC license number 24-18683-01 is hereby terminated.
