Enclosed is Amendment No. 31 amending your NRC Material License No. 13-16680-01 in accordance with your request. Please note that the changes made to your license are printed in **bold font**.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

This also refers to your letter dated May 11, 2012, notifying the NRC of the transfer of ownership and control of License No. 13-16680-01 issued to Hammond Clinic.

The transferee should note their new responsibility and liability as an NRC licensee. Specifically, responsibility is emphasized with regard to any ongoing NRC inspection and enforcement issues, investigations, facility decontamination and decommissioning funding resources. Please be advised, change of ownership/control cannot be transferred without **prior written consent** from the NRC (10 CFR 30.34 (b)).
