SUBJECT: TRANSPORT LOGISTICS INTERNATIONAL INC - NRC INSPECTION AND
NOTICE OF VIOLATION

Dear Mr. Lambert:

This letter refers to the inspection completed at the Transport Logistics International Inc. (TLI), Fulton, Maryland facility on May 16, 2012, as documented by the U.S. Nuclear Regulatory Commission (NRC) Office of International Programs (OIP) inspection report dated June 21, 2012. Export license XSNM3649 authorizes TLI to export 90 grams of plutonium (Pu)-239 and 75 grams of uranium (U)-235 in 10 irradiated fuel rods. On November 23, 2010, TLI exceeded the limits of export license XSNM3649 by exporting 180 grams of plutonium, including 110 grams of fissile (Pu-239 and Pu-241), to Sweden. In addition, export license XSNM3704 authorizes TLI to export 4,952 kg of U-235 in 104,264 kg of uranium, and authorizes export of Canadian obligated material. On March 19, 2012, TLI exported Australian obligated material to the Republic of Korea under XSNM3704.

Based on the results of the inspection, and previous email communications with OIP on and subsequent to January 30, 2012, and April 12, 2012, the NRC has determined that two Severity Level IV violations of NRC requirements occurred. These violations were evaluated in accordance with the NRC Enforcement Policy available on the NRC's website at <http://www.nrc.gov/about-nrc/regulatory/enforcement/enforce-pol.html>. The violations are cited in the enclosed Notice of Violation (Notice). The violations are being cited because the NRC identified them.

You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. If you have additional information that you believe the NRC should consider, you may provide it in your response to the Notice. The NRC review of your response to the Notice will also determine whether further enforcement action is necessary to ensure compliance with regulatory requirements.

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter, its enclosures, and your response, will be made available electronically for public inspection in the NRC Public Document Room or from the NRC's document system Agencywide Documents Access and Management System, accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>.
