PURPOSE: The purpose of this predecisional enforcement conference is to discuss five apparent violations of NRC requirements involving failures to: (1) secure the portable gauge using two independent physical controls to prevent unauthorized removal, while in storage; (2) perform (at least annually) a review of the radiation safety program; (3) test sealed sources for leakage annually; (4) conduct physical inventories of sealed sources every 6 months; and (5) have a lock on the gauge or outer locked container designed to prevent unauthorized or accidental removal of the sealed source from its shielded position.

CATEGORY: This is a Category 1 meeting. The public is invited to participate telephonically in this conference and will have one or more opportunities to communicate with the NRC after the business portion, but before the meeting is adjourned. Members of the public can listen to the meeting via a special telephone line by calling 1-817-200-1279 and asking to be connected to the meeting.
