Reference Task Order ADM-001 under Contract NRC-10-07-414.

The purpose of this modification is to (1) extend the task order period of performance, (2) increase the task order ceiling amount, and (3) add incremental funding, as follows:

1. Extend the task order period of performance for six months, from September 21, 2012 through March 20, 2013. The revised period of performance will be October 15, 2007 through March 20, 2013.
2. Increase the task order estimated ceiling amount by \$242,903.20, from \$1,452,706.42 to \$1,695,609.62. An estimated price schedule showing revised Option Year Four and the six-month extension, as well as the total task order ceiling in the amount of \$1,695,609.62, is attached.
3. Add incremental funding in the amount of \$275,000.00, thereby increasing the obligated amount from \$1,339,889.80 to \$1,614,889.80.
