Dear Mr. Conrad:

This is in reference to your current financial assurance instrument, an escrow account. Escrow accounts will no longer be acceptable as of December 17, 2012. The NRC published the new financial assurance rules in the Federal Register Notice dated June 17, 2011 [(Volume 76, No. 117, pages 35512 – 35573) ADAMS Accession No. ML121350224]. The NRC is revising 10 CFR 30.35, 10 CFR 40.36 and 10 CFR 70.25 which apply to your Nuclear Regulatory Commission License Nos. 08-02075-03, SUD-157, and SNM-164. Please review the Federal Register Notice and provide the NRC with a new financial assurance instrument. Respond by September 20, 2012. We must review, resolve any discrepancies, and approve your new financial assurance instrument before December 17, 2012.
