The following is a complete description of this modification:

(1) Add FAR clause 52.217-89, entitled "Option to extend services", (2) extend the contract period of performance through 11/30/12, (3) and provide funding in the amount of \$135,538.00, thereby increasing the obligation amount of this contract from \$2,381,072.04 to \$2,516,610.04.

Accordingly, the following section is added to this contract:

Section C.18, FAR Clause 52.217-8 OPTION TO EXTEND SERVICES (NOV 1999)

The Government may require continued performance of any services within the limits and at the rates specified in the contract. These rates may be adjusted only as a result of revisions to prevailing labor rates provided by the Secretary of Labor. The option provision may be exercised more than once, but the total extension of performance hereunder shall not exceed 6 months. The Contracting Officer may exercise the option by written notice to the Contractor within 15 days.

Accordingly, the following changes are hereby made:

Section B.5, DURATION OF CONTRACT PERIOD (MAR 1987 ALTERNATE 2 (MAR 1987)) is revised to read:

The period of performance of this contract shall commence on the August 11, 2008 and will expire on November 30, 2012.
