The purpose of this modification is to:

1. Exercise the Government's unilateral right to exercise an option in accordance with the contracts clause FAR 52.217-9, Option to Extend the Term of the Contract.

The period of performance of Option Year I is September 26, 2012 to September 25, 2013.

The Government hereby exercises Option No. 1 at the rates priced in Section B of the contract.

The full contract period of performance is change to read March 16, 2012 to September 25, 2013.

2. Increase the task order ceiling by \$743,206.64, from \$378,254.39, Accordingly, paragraph (a) under section B.4 Consideration and Obligation-Time and Materials Contract (August 2011) is revised to read as follows:

"(a) Currently, the ceiling price to the Government for full performance under this contract is \$1,121,461.03."

3. Add incremental funding in the amount of \$56,000, thereby increasing the obligated amount from \$325,000.00 to \$381,000.00

All other terms and conditions remain unchanged.
