Dear Mr. Hamrick:

On July 19, 2012, the U. S. Nuclear Regulatory Commission (NRC) completed a security baseline inspection at your Shearon Harris Nuclear Power Plant, Unit 1. The inspection covered one or more of the key attributes of the security cornerstone of the NRC's Reactor Oversight Process. The enclosed report documents the inspection results, which were discussed with you and other members of your staff.

This inspection examined activities conducted under your license as they relate to security, and compliance with the Commission's rules and regulations, and with the conditions of your license. The inspectors reviewed selected procedures and records, observed activities, and interviewed personnel.

One finding of very low security significance (i.e., Green as determined by the Physical Protection Significance Determination Process) was identified during this inspection. The deficiency was corrected or compensated for, and the plant was in compliance with applicable physical protection and security requirements within the scope of this inspection before the inspectors left the site. The finding did not have a cross-cutting aspect. The NRC is treating this violation as a non-cited violation (NCV) consistent with Section 2.3.2, of the NRC Enforcement Policy because of the very low safety significance of the violation, and because it was entered into your corrective actions program. If you contest this non-cited violation, you should provide a response within 30 days of the date of this inspection report, with the basis of your denial, to the Nuclear Regulatory Commission, Administrator, Region II; the Director, Office of Enforcement, United States Nuclear Regulatory Commission, Washington, DC 20555-0001; and the NRC Resident Inspector at the Shearon Harris Nuclear Station.
