The purpose of this modification is to:

1. Exercise the Government's unilateral right to exercise an option in accordance with the contracts clause FAR 52.217-9, Option to Extend the Term of the Contract. Accordingly, the full contract period of performance is changed to read:

"March 5, 2012 – September 25, 2013".

The Government hereby exercises Option No. 1 at the rates priced in Section B of the contract.

2. Increase the task order ceiling by \$108,758.02, from \$83,189.57 to \$191,947.59. Accordingly, paragraph (a) under section B.4 Consideration and Obligation-Time and Materials Contract (August 2011) is revised to read as follows:

"(a) currently, the ceiling price to the Government for full performance under this contract is \$191,947.59."

3. Add incremental funding in the amount of \$45,000, thereby increasing the obligated amount from \$60,000.00 to \$105,000.
4. Add cost reimbursable travel to task order NRC-HQ-12-T-42-0015. As a result, Section B is revised to read the following:

B.4 CONSIDERATION AND OBLIGATION-TIME-AND-MATERIALS CONTRACT (AUG 2011)

- (a) Currently, the ceiling price to the Government for full performance under this contract is \$191,947.59.
- (b) The contract includes: (1) direct labor hours at specified fixed hourly rates, inclusive of wages, fringe, overhead, general and administrative expenses, and profit, totaling \$102,000; and (2) cost of materials totaling \$0.00. **(3) cost reimbursable travel not to exceed \$3,000.**
- (c) The amount presently obligated by the Government with respect to this contract is \$105,000, with \$3,000 being for cost reimbursable travel.
- (d) This is an incrementally-funded contract and FAR 52.232-22 - "Limitation of Funds" applies

B.5 2052.215-81 TRAVEL REIMBURSEMENT

- (a) Total expenditure allotted for domestic travel may not exceed without the prior approval of the contracting officer.
- (b) The contractor is encouraged to use Government contract airlines, AMTRAK rail services, and discount hotel/motel properties in order to reduce the cost of travel under this contract. The contracting officer shall, upon request, provide each traveler with a letter of identification which is required in order to participate in this program. The Federal Travel Directory (FTD) identifies carriers, contract fares, schedules, payment conditions, and hotel/motel properties which offer their services and rates to Government contractor personnel traveling on official business under this contract. The FTD, which is issued monthly, may be purchased from the U.S. Government Printing Office, Washington, DC 20402.
- (c) The contractor will be reimbursed for reasonable travel costs incurred directly and specifically in the performance of this contract. The cost limitations for travel costs are determined in accordance with the specific travel regulations cited in FAR 31.205-46, as are in effect on the date of the trip.
- (d) When the Government changes the Federal Travel Regulations, or other applicable regulations, it is the responsibility of the contractor to notify the contracting officer in accordance with the Limitations of Cost clause of this contract if the contractor will be unable to make all of the approved trips and remain within the cost and fee limitations of this contract due to the changes.
