SUMMARY

This refers to your letter dated July 9, 2012, responding to my conversation record dated April 16, 2012 and our telephone discussion on May 9, 2012.

This also refers to my letter to you dated June 28, 2012, transmitting Amendment No. 93, a two-year renewal of your license as a Type A broad scope.

Your letter dated July 9, 2012, failed to address most of the items in my record dated April 16, 2012, as well as the items in my letter dated June 28, 2012 (many of which were repeated from the April 16, 2012, record, for completeness' sake).

I left voicemail messages for Dr. Jursinic at 3:09 p.m. CT today and for Mr. Mushett at 3:30 p.m. CT today, July 26, 2012. My messages summarized the information below.

Since we seem to be at an impasse regarding progress with this license, I've consulted my acting Branch Chief about your current licensing situation. He directed me to call you both and to void the letter dated July 9, 2012, as it does not contain anything we can use to amend the license.

In addition, it would be best to schedule a telephone conference call between you and me and my management to discuss whatever remains unclear about how to downgrade this license from a broad scope to a limited scope license.

When we've spoken about this matter recently, on several occasions, I've asked you if each point I've made and information requested is clear and you've indicated that it was. However, we still do not have responses addressing most of the information we've requested and discussed.

Please let me know when you are available to schedule a conference call during either the weeks of July 30th – August 2nd, 2012, or August 13 – August 17, 2012. I will be out of state at a training course for NRC during the week of August 5 – 10.

Please also be reminded of the provisions in 10 CFR 30.9(a), "Completeness and accuracy of information,"...(a) Information provided to the Commission by an applicant for a license or by a licensee or information required by statute or by the Commission's regulations, orders, or license conditions to be maintained by the applicant or the licensee shall be complete and accurate in all material respects."

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the NRC's Agencywide Documents Access and Management System (ADAMS), accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>.

ACTION REQUIRED

As we cannot issue an amendment at this time we are "voiding" this request in order to enable you to prepare a quality response without time constraints. This is done without prejudice to the resubmission of your request at a later date. Upon receipt of your response we will resume our review. However, please note that your license will expire on June 30, 2014.


