Dear Sir or Madam:


In Reference 1, Entergy Nuclear Operations, Inc. ("Entergy") provided comments on the Proposed Director's Decision Under 10 CFR 2.206 (Reference 2). When providing these comments Entergy noted that the resolution of Unit 3 Operator Manual Action (OMA) 10 required a modification that would require a plant outage to install. Accordingly, Entergy stated that a revision to the initial OMA RAI response (Reference 3) was necessary and that the revision would be submitted by August 17<sup>th</sup> 2012. On August 14, 2012 Douglas Pickett of your staff and I verbally agreed that Entergy will submit that revision by September 6, 2012.
