Reference Task Order OCFO-001 under Contract NRC-10-07-414.

The purpose of this modification is to (1) extend the task order period of performance, (2) increase the task order ceiling amount, and (3) add incremental funding, as follows:

1. Extend the task order period of performance for six months, from September 21, 2012 through March 20, 2013. The revised period of performance will be November 6, 2007 through March 20, 2013.
2. Increase the task order estimated ceiling amount by \$25,174.26, from \$888,699.69 to \$913,873.95.
3. Add incremental funding in the amount of \$40,000.00, thereby increasing the obligated amount from \$873,873.95 to \$913,873.95.
