On August 6-9, 2012, Mr. Robert Evans of NRC Region IV visited your site for the purpose of conducting a routine decommissioning safety inspection. Accompanying Mr. Evans was Dr. D. Blair Spitzberg, Chief of the Fuels Safety and Decommissioning Branch in Region IV and three decommissioning representatives from the Iraq Ministry of Environment, Radiological Protection Centre: Mr. Shaker Hamed Rayiss Al-Ani, Mr. Hayder Hussein Hadi Eesee, and Mr. Ahmed Adil Shihab Al-Tameemi. The three Iraqi representatives were being supported by the International Atomic Energy Agency to observe the NRC inspection processes associated with active decommissioning sites.
