


The purpose of this modification is (1) to increase the level of effort of the basic work by 100 staff hours under Task 3 to perform re-code results verifications, water resources data updates, and the potential development of recreating of new figures for the Environmental Assessment; (2) to exercise Optional Tasks 5A and 5B; (3) to incrementally fund the task order in the amount of \$117,172; and (4) extend the period of performance through August 30, 2013.

Accordingly the following changes are made:

1. Section 1 CONSIDERATION AND OBLIGATION--COST PLUS FIXED FEE (JUN 1988) ALTERNATE I (JUN 1991) is deleted in its entirety and replaced with the following:

- (a) The total estimated cost to the Government for full performance of this task order is **\$270,681**, of which the sum of **\$259,630** represents the estimated reimbursable costs, and of which **\$20,051** represents the fixed fee.
- (b) There shall be no adjustment in the amount of the Contractor's fixed fee by reason of differences between any estimate of cost for performance of the work under this contract and the actual cost for performance of that work.
- (c) The amount currently obligated by the Government with respect to this contract is **\$183,846**, of which the sum of **\$170,228** represents the estimated reimbursable costs, and of which **\$13,618** represents the fixed fee.
