

The purpose of this modification is (1) to exercise the optional period, (2) to increase the Maximum Ordering Limitation by \$1,490,134, from \$13,948,541 to \$15,438,675 and (3) to extend the contract through September 28, 2013.

Therefore, the following changes are made to the contract:

1. Section B.2, CONSIDERATION AND OBLIGATION--TASK ORDERS (AUG 1989) ALTERNATE 1 (JUN 1991) is hereby deleted in its entirety and replaced with the following:

B.2 CONSIDERATION AND OBLIGATION--TASK ORDERS (AUG 1989) ALTERNATE 1 (JUN 1991)

(a) The Maximum Ordering Limitation (MOL) for products and services ordered, delivered and accepted under this contract is **\$15,438,675 (Base Period and Option Year One)**. If **Optional Year 2** is exercised, the MOL will increase by **\$1,498,907**. The Contracting Officer may place orders with the contractor during the contract period provided the aggregate amount of such orders does not exceed the MOL.

(b) The guaranteed minimum obligated by the Government under this contract is **\$1,200,000**.

(c) A total estimated cost as well as any fee, if any, will be negotiated for each task order and will be incorporated as a ceiling in the resultant task order. The Contractor shall comply with the provisions of 52.232-20 - Limitation of Cost for fully funded task orders and 52.232-22 - Limitation of Funds for incrementally funded task orders, issued hereunder.

2. Section F.6 DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 4 (JUN 1988) is hereby deleted in its entirety and replaced with the following:

F.6 DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 4 (JUN 1988)

The ordering period for this contract shall commence on **September 29, 2009** and will expire on **September 28, 2013, with one additional Option Year**. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering.)

All other terms and conditions remain unchanged.
