2) Physical Description

This shipment will consist of 126 drums of Uranium Ore Concentrate (U-308) in 2 x 20' ocean containers. The total weight of the shipment is 28,043.7 kgs of U-308.

3) Transportation and Route Schedule

The vessel is scheduled to sail from Adelaide on May 21, 2012. The ocean transportation from Adelaide to Seattle, WA USA will be the responsibility of Hamburg Sued. The vessel will unload at Seattle, WA USA on or about June 15, 2012. The inland transportation from Seattle, WA to Blind River, ON will be the responsibility of RSB LOGISTIC SERVICES, INC.
