Subject: Advance Notification of Export Shipment (Additional Schedule Revision)

In accordance with the requirements for Implementation of the Convention of the Physical Protection of Nuclear Material, AREVA NP Inc. is submitting the revised information below regarding our upcoming export shipment to Taiwan under export license XSNM3551 Amendment No. 1. This notification constitutes a revision of our most recent notification (LJM:12:011; May 15, 2012) for this export shipment. The present revision changes the departure date from Richland from June 7 to June 6, 2012. All other transport information remains unchanged.

2. Physical Description

One hundred sixty four (164) unirradiated, low-enriched uranium fuel assemblies contained in eighty two (82) sealed shipping containers. The shipment is being transported in seven sea containers. The shipment contains approximately 29,125 KgU and 1,178 KgU²³⁵ at an average enrichment of approximately 4.04 wt% U-235 (based on design weight).

3. Transport Route

The shipment will depart from Oakland, CA via the vessel "YM Mutuality" going to Keelung, Taiwan. Upon arrival at Keelung, the Taiwan Power Company, or its agent, will take physical custody of the shipment as arranged prior to shipment.

4. Schedule

The shipment is scheduled to depart Richland, WA on June 6, 2012, to depart Oakland, CA on June 9, 2012, and expected to arrive at Keelung, Taiwan on June 27, 2012.

5. Assurance

The shipment will be protected during transport in accordance with IAEA Information Circular 225, "Physical Protection of Nuclear Materials".
