This letter refers to our meeting at the NRC Region II Office in Atlanta, Georgia on August 27, 2012, during which you presented information related to the apparent violations associated with the failure to identify credible accident sequences related to seismic events and tornadoes that could result in large uranium hexafluoride (UF<sub>6</sub>) releases for which protective actions may be needed. The meeting afforded the members of the public the opportunity to ask questions and provide feedback to the NRC regarding NRC's activities regarding Honeywell after the business portion of the meeting.
