**ORDER**

The Atomic Safety and Licensing Board issued three decisions in this proceeding on August 30, 2012.<sup>1</sup> Applicants Calvert Cliffs 3 Nuclear Project, LLC, and UniStar Nuclear Operating Services, LLC have filed an unopposed request that the Commission apply the deadlines associated with the new rules of practice<sup>2</sup> to any appeals (and answers) relating to the three Board decisions.<sup>3</sup>

Pursuant to my authority under 10 C.F.R. § 2.346(j), the request is granted. The new rules, which became effective on September 4, 2012, will apply to any petitions for review of the Board decisions.<sup>4</sup>
