To Whom It May Concern:


Pursuant to the provisions of the Federal Freedom of Information Act (FOIA), codified at 5 U.S.C. §552, I hereby request any records, reports, or portions thereof maintained by your agency, pertaining to any violations, enforcement actions, inspection and/or compliance reports, proposed imposition of civil penalties, violations of the National Environmental Policy Act or waste disposal practices in connection with the following St. Louis Formerly Utilized Sites Remedial Action Program ("FUSRAP") sites located in North St. Louis County and the Westlake Landfill:

- The St. Louis Downtown Site (SLDS) – 45 acre industrial area on the eastern border of St. Louis owned and operated by Mallinckrodt Inc.
- The St. Louis Airport Site (SLAPS) – 21.7 acre property immediately north of the Lambert-St. Louis International Airport.
- The Latty Avenue Properties:
  - Hazelwood Interim Storage Site – Eastern portion of 9200 Latty Ave.
  - Futura Coatings Site – western portion of 9200 Latty Ave.
  - Latty Avenue Vicinity Properties:
- The Madison Site – located at College and Weaver Streets in Madison, IL (across the river from the SLDS).
- The West Lake Landfill is located at 13570 St. Charles Rock Road, Earth City Industrial Park in Bridgeon, IL.

Please advise as to the charge for reproduction costs concerning same, and we will promptly remit payment for the reasonable duplication fees. Should any part of this request be denied, either in whole or in part, I ask that you cite specific exemptions to the Federal Freedom of Information Act, and provide an adequate description of the exempted document in order to allow for an appeal. We further ask that any reasonable, separable parts of otherwise exempt material be released. We reserve the right to appeal any decision to withhold information.
