We, Cheryl Marie, and, Michael Patrick, hereon also 'we' and 'our' and 'us', with ministerial right as covenant- bondservants of Nature's God (God, the Creator) moving the Public-interest with full responsibility for the Public-benefit, make known hereby this Closedown-Document our election-claim of the closedown of the Donald C. The facts founding our election, declaration of trust and terms follow hereon (1-9):

For the word-terms: Federal-Postal-Vessel=this document in the 1775 [founded] Post Office for the contract with the Postmaster General.

: Michigan-Territory= the land-survey (soil and boundary) by the volition of the people (electors) with the society-bond: The State of Michigan with the federation-union: The United States of America [with the Articles of Confederation and Perpetual Union and the Northwest Ordinance].
