Subject: Annual Notification of Foreign Ownership, Control, or Influence (FOCI) Status

Connecticut Yankee Atomic Power Company (CY) hereby provides the requested annual notification of its FOCI status in accordance with the NRC's letter dated March 2, 2012 (Reference 1). In this letter, the NRC notified CY of a favorable FOCI determination, granted CY a non-possessing facility security clearance in accordance with 10 CFR 95, and provided a set of general FOCI requirements that included a requirement for CY to submit an annual written notification of the company's FOCI status. In a telephone call with the NRC on January 8, 2013, compliance with the annual reporting requirement stipulated in the NRC letter dated March 2, 2012, was identified as voluntary.

On May 9, 2012, CY submitted a notice of change in ownership structure in accordance with 10 CFR 95.17(a)(1) (Reference 2) regarding the completed merger between Northeast Utilities and NSTAR, with Northeast Utilities as the surviving company. This merger involved two indirect non-licensed CY shareholders, both of which are U.S. Companies. The combined Northeast Utilities is a U.S. Company.

On July 16, 2012, CY submitted a notice of change in ownership structure in accordance with 10 CFR 95.17(a)(1) (Reference 3) regarding the completed merger between Central Vermont Public Service Corporation (CVPS) and Gaz Métro Limited Partnership (Gaz Métro). CVPS owned 2% of the outstanding common stock of CY. As a result of that transaction, CVPS became an indirect wholly-owned subsidiary of Gaz Métro. CVPS was a Vermont corporation. Gaz Métro is a Canadian energy company. On June 15, 2012, in a letter to CVPS (Reference 3), the NRC concluded that the proposed merger between CVPS and Gaz Métro did not require the NRC's approval under Section 184 of the Atomic Energy Act of 1954, as amended, and 10 CFR 50.80 with respect to the licenses for CY, Maine Yankee Atomic Power Company

(MY), and Yankee Atomic Electric Company (YAEC). In addition, the NRC concluded that the foreign ownership, control, or domination of the CY, MY, and YAEC licensees has been negated by existing Negation Action Plans (NAPs) (Reference 4).


On October 30, 2012, CY submitted a notice of change in indirect ownership regarding the merger between CVPS and Green Mountain Power (GMP), with GMP as the surviving company (Reference 5). GMP is an electric utility operating in Vermont. CVPS and GMP are both wholly-owned subsidiaries of Gaz Métro. On September 7, 2012, the NRC concluded that the proposed merger between CVPS and GMP did not require the NRC's approval under Section 184 of the Atomic Energy Act of 1954, as amended, and 10 CFR 50.80 with respect to the licenses for CY, MY, and YAEC. In addition, the NRC concluded that the foreign ownership, control, or domination of the CY, MY, and YAEC licensees has been negated by existing NAPs (Reference 6).

Besides the changes discussed above, there have been no other significant changes relating to CY's Certificate Pertaining to Foreign Interests submitted as enclosures to a letter dated January 3, 2012 (Reference 7), on which the NRC's FOCI determination was rendered (Reference 1).

This letter contains no regulatory commitments.
