SUBJECT: RECORD OF 6-MONTH CONFERENCE CALL

Dear Mr. Millar:

This is to document the conference call conducted on February 14, 2013, between you, and the following members of my staff, Messrs. Michael Vasquez and Jason Razo, and Ms. Vivian Campbell. The purpose of the call was to discuss the status of your compliance with the CONFIRMATORY ORDER MODIFYING LICENSE (EFFECTIVE IMMEDIATELY) issued on June 7, 2011.

The topics that were discussed included the second independent audit conducted from January 30 to February 5, 2013, internal quarterly audits, willfulness training for new employees, and the NRC inspection conducted on August 29, 2012. You stated that you conducted audits of radiography crews in the field, and you attempted to perform these audits without being detected by the crews. You stated that you assisted the independent auditor with his audit and implemented his recommendations for enhancement of your radiation safety program.

You are not required to respond to this letter.
