SUBJECT: SUMMARY OF WEEKLY CONFERENCE CALL MEETING TO DISCUSS OPEN ITEMS AND OUTSTANDING REQUESTS FOR ADDITIONAL INFORMATION RESPONSES RELATING TO DTE ELECTRIC COMPANY'S FERMI 3 COMBINED LICENSE APPLICATION

On Thursday, February 14, 2013, the U.S. Nuclear Regulatory Commission's (NRC) staff held a public conference call from 1:00 pm to 2:00 pm with members of DTE Electric Company. The purpose of the conference call was to discuss the status of the remaining open items (OI) related to the Fermi 3 Combined License Application. 1. Staff comments related to RAI Letter No 77 response - Fukushima Recommendation 2.1 - **DTE Electric agreed to supplement their RAI response by providing target response spectra values– to be submitted within 2 weeks (2/28/2013)**
2. Staff comments related to Chapter 1 RAI responses 01-8, 9, 10 and 11 - **DTE Electric proposed to:**
 - 1) revise FSAR table 1.9-201 in their RAI response for RAI 01-08 to list BTP 5-4 as "Conforms; "
 - 2) revise FSAR table 1.9-201 in the RAI response for RAI 01-08 to list SRP 10.3 acceptance criteria II.4 as "Conforms". In addition, the applicant may further revise the table to clarify that II.4.A "Conforms" and II.4.B "Not applicable to ESBWR;"
 - 3) revise FSAR table 1.9-203 in the RAI response for RAI 01-09 to list item C.III.1 17.4.2 as "Conforms. Addressed in Section 17.4 and DCD Section 17.4" – to be submitted within 2 weeks (2/28/2013)
