Our By-Products Material License No. 47-16875-02 will expire on December 31, 1987. We are requesting a 90-day extension of our license by Amendment to continue to store the units on site at the facility. This Amendment, extending the storage period, will allow us to either return the units to the manufacturer or dispose of them via an approved contractor.

We will continue to store the units in a labeled, secure storage cabinet at the Monessen facility. The plant has recently been idle due to current Chapter 11 Bankruptcy proceedings of Wheeling-Pittsburgh Steel. The units will be surveyed and wipe tested upon removal from storage for disposal. Upon their disposition, we will complete and submit a "Certification of Disposition of Materials Form" to you.
