This RAI addresses the Ultimate Heat Sink as discussed in Section 9.2.5 of the Final Safety Analysis Report (FSAR), as submitted in Part 2 of the Bell Bend Nuclear Power Plant (BBNPP) Combined License Application (COLA).

Reference 3 provided our response to RAI No. 115 Question 09.02.05-29-part-1.

PPL requires additional time to provide a response to RAI No. 115 Question 09.02.05-29-part 2 through part 6. The response to RAI No. 115 Question 09.02.05-29-part 2 through part-6 will be provided on or before June 28, 2013.

The only new commitment in this letter is to provide a response to RAI No. 115, Question 09.02.05-29-part 2 through part 6 on or before June 28, 2013.


