The purpose of this modification is to increase the obligated amount by \$15,000 from \$66,000 to \$81,000 and to change the name of the contracting officer representative. Accordingly, the task order is modified as follows:

1. Paragraph (c) of section A.1 entitled: "Consideration and Obligation - Cost Plus Fixed Fee" is revised to read as follows:

"(c) The amount obligated by the Government with respect to this task order is \$81,000.00."
