Dave Misenhimer informed me that STP should address STP ACRS Action Items 61 and 65 during the March 20, 2013 ACRS Meeting.

We can address these items; however, Action Item 61 (including the follow-up question on hydrodynamic drag) is already closed.

The Official Transcript for the November 30, 2010 ACRS meeting shows Action Item 61 being discussed beginning on page 38, line 23.

The follow-up question is asked on page 39, line 18. Chairman Abdel-Khalik closed the item on page 130, line 12.

The status of Action Item 61 is also discussed in the "Certification Of The Minutes of the ACRS ABWR Subcommittee Meeting, November 30, 2010, Rockville, Maryland," dated January 13, 2011. Action Item 61 is discussed at the bottom of page 3.
