
The purpose of this modification is to: 1. Increase the task order ceiling by \$1.5 million to accommodate for an increase in the level of effort for work being completed under the current SOW. Accordingly, the task order ceiling is increased by \$1,500,000.00 from 3,270,097.50 to \$4,770,097.50. 2. Obligate funds in the amount of \$575,000.00, thereby increasing the total obligated amount from \$2,995,724.00 to \$3,570,724.00.
