WITNESSETH:

WHEREAS, the undersigned is a licensee of the U.S. Nuclear Regulatory Commission (NRC).

WHEREAS, the NRC is providing the following data to Holtec for the purpose of re-calibration of the computer model that Holtec International is using on HI-STORM 100 License Amendment Request No. 9 Thermal Analysis.

- The data provided is the volumetric flow, ambient temperature and maximum cladding temperature at the elevations of 136 and 142 inches as a function of time for the 1 kW separate effect test performed on 2/16/2011. This separate effect test is part of the first phase of the OECD/NEA Spent Fuel Pool Project to study pressurized-water reactor spent fuel heat-up and propagation phenomena.

The above mentioned data is Sensitive Unclassified Non-Safeguards Information (SUNSI) and Official Use Only (OUO). Handling of such documents has to be done in accordance with the SUNSI policies and procedures attached.

NOW, THEREFORE, Holtec agrees as follows:

1. Holtec acknowledges that the information obtained from the NRC is considered by the NRC to contain OUO information.
2. Holtec agrees to treat and safeguard the information as containing OUO information and will not copy or use such information other than for the sole aforementioned purpose without express, written authorization from the NRC. Holtec will not release information to any third party without the third party establishing prior non-disclosure agreement (NDA) directly with NRC. This includes identified Holtec staff requiring this information. Holtec will not release this data to the public.
