Dear Mr. Davis:

On January 30, 2013, with continuing in-office review through February 12, 2013, a U.S. Nuclear Regulatory Commission (NRC) inspector conducted a routine inspection at your Flint, Michigan facility. The purpose of the inspection was to review activities performed under your NRC license to ensure that activities were being performed in accordance with NRC requirements. The in-office review included a review of the licensee's procedures, and other information. A final exit meeting was held between Bill C. Lin of my staff and Pat Durkin, Chris Dugan, and yourself by telephone on February 13, 2013.

During this inspection, the NRC staff examined activities conducted under your license related to public health and safety. Additionally, the staff examined your compliance with the Commission's rules and regulations as well as the conditions of your license. Within these areas, the inspection consisted of selected examination of procedures and representative records, observations of activities, and interviews with personnel.

Based on the results of this inspection, the NRC has determined that one Severity Level IV violation of NRC requirements occurred. The violation was evaluated in accordance with the NRC Enforcement Policy. The current Enforcement Policy is included on the NRC's Web site at <http://www.nrc.gov/about-nrc/regulatory/enforcement/enforce-pol.html>. The violation involved security failures. The violation is cited in the enclosed Notice of Violation (Notice) and the circumstances surrounding it are described in detail in the non-public Security Addendum (enclosed). The violation is being cited in the Notice because it was identified by the NRC inspector.

The NRC has concluded that information regarding the reason for the violation, the corrective actions taken and planned to be taken to correct the violation and prevent recurrence, and the date when full compliance will be achieved, is already adequately addressed on the docket in the Security Addendum to this letter and the subject inspection report. Therefore, you are not required to respond to this letter unless the description herein does not accurately reflect your
