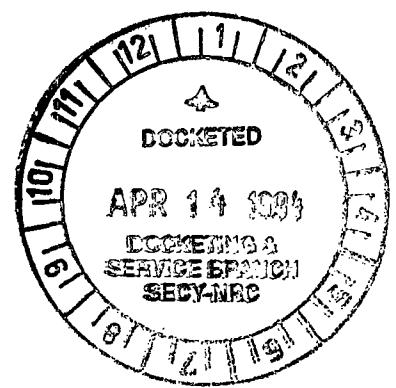

**NATIVE AMERICANS FOR A CLEAN ENVIRONMENT'S
MOTION FOR CONSOLIDATION AND/OR EXTENSION
OF BRIEFING SCHEDULE**

On April 7, 1994, Sequoyah Fuels Corporation ("SFC") filed a Notice of Appeal and Brief challenging LBP-94-5, the Licensing Board's March 3, 1994, order which admits Native Americans for a Clean Environment ("NACE") as an intervenor in this proceeding. In addition, the Commission is now considering whether to accept the Licensing Board's referral of certain of the issues decided in LBP-94-5.

NACE wishes to conserve its resources and avoid the wasted time and expense involved in briefing the same issues twice. NACE also believes that the ten-day response period provided by 10 C.F.R. 2.714a is inadequate to allow a meaningful opportunity to respond to SFC's brief, which is almost 30 pages long. Moreover, pursuant to CLI-94-04 (April 1, 1994), NACE must also prepare an appellate brief in the license renewal case for the SFC facility during the same time period (i.e., by May 1, 1994).

Accordingly, NACE requests that if the Commission decides to take review of LBP-94-5, it consolidate that proceeding with

SFC's appeal of LBP-94-5, and require a single brief from NACE on the issues raised by the referral and SFC's appellate brief. NACE asks that any briefing schedule established by the Commission provide it with a reasonable opportunity to prepare a response to the issues raised in SFC's appellate brief, or at least 30 days from NACE's receipt of SFC's brief.

In the alternative, if the Commission decides not to accept the Licensing Board's referral, NACE requests an extension to provide it with a 30-day period in which to file a reply to SFC's brief, or until May 11, 1994.

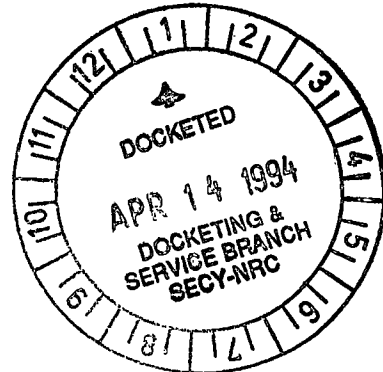
