The purpose of this contract modification is to provide incremental funding in the amount of \$100,000.00, thereby increasing the obligated amount from \$827,000.00 to \$927,000.00. Accordingly, paragraph (b) of section B.3 entitled: Consideration and Obligation - Cost Reimbursement- Alternate I (JUN 1988), is revised to read as follows:

"(b) The amount presently obligated by the Government with respect to this contract is \$927,000.00."
