SUBJECT: CY 2012 BASELINE INSPECTION COMPLETION

During calendar year 2012, Region IV completed the baseline inspection program at twelve of the thirteen regional reactor licensees subject to the Reactor Oversight Process (ROP).

Attached is a table which provides the completion status of individual baseline procedures (IR Report 8a). Please note that these data include only activities for which the region had responsibility; those portions of the baseline inspection program for which other NRC organizations are responsible are not included.

At Grand Gulf Nuclear Station, inspectors began the required annual sample of Inspection Procedure (IP) 71111.11, "Licensed Operator Requalification Program and Licensed Operator Performance," on December 20, 2012, but did not complete it prior to the end of the calendar year. The inspection was completed on February 6, 2013. It will be documented in the integrated inspection report for the first quarter of 2013. This satisfies the requirements of Inspection Manual Chapter (IMC) 2515 for baseline inspection program completion.

At San Onofre Nuclear Generating Station, inspectors began the biennial portion of IP 71111.11, "Licensed Operator Requalification Program and Licensed Operator Performance," on July 30, 2012, but because required information was not available from the licensee until December 17, 2012, the activity was not completed prior to the end of the calendar year. Though the attached table indicates that both the annual and biennial IP 71111.11 activities were incomplete, only one was required. The biennial inspection was completed February 21, 2013. The results will be documented in the integrated inspection report for the first quarter of 2013. This satisfies the requirements of IMC 2515 for baseline inspection program completion.

Also at San Onofre Nuclear Generating Station, inspectors completed seventeen of the eighteen required samples of IP 71111.22, "Surveillance Testing." The final required sample will be completed during the first calendar quarter of 2013.

I have reviewed the three required inspection samples that were not completed by the end of calendar year 2012. I have determined that these incomplete samples did not adversely affect

the NRC's ability to assess performance at either of the affected sites. Region IV is reviewing these instances to determine the reasons for not completing the inspection samples by the end of the year. We will take corrective actions as appropriate.

Effective September 4, 2012, San Onofre was transitioned to IMC 0351 oversight. As part of this transition, Region IV adopted an inspection plan that modified the baseline ROP requirements at San Onofre (ML12242A518). The procedures for which the minimum baseline samples were not completed, but for which the requirements of the IMC 0351 inspection plan were fully accomplished, are annotated in the attached table as "Complete by reference."

Fort Calhoun was transitioned from the IMC 0305 ROP to IMC 0350 oversight effective December 11, 2011. The licensee remained in IMC 0350 oversight for entire calendar year 2012 inspection cycle. Ongoing inspection activities at Fort Calhoun were managed by the IMC 0350 process; the minimum inspection requirements of the ROP did not apply.
