Individual Sessions

"The NRC Contracting Officer Representative (COR) will send the contractor completed career counseling registration forms will include work phone number(s), and work email(s). The contractor shall make all of the arrangements for career counseling appointments directly with the NRC participant. This should be accomplished within 3 days of receiving the registration form. The contractor can schedule blocks of time, if so desired, as long as it is not too restrictive for allowing flexible scheduling of appointments by participants. The total amount of sessions per month shall not exceed 15, unless permission is granted by the COR via e-mail or other form of written communication. Career counseling sessions can be conducted via telephone, Skype, and VTC.
