The contract was completed November 30, 2011 for the amount of \$10,176,106.97, as indicated on the contractor's final release received March 11, 2013. The total amount obligated is hereby decreased by \$194,393.03, changing the total amount obligated from \$10,370,500.00 to \$10,176,106.97.
